2.5.2 – Reforms initiated on Continuous Internal Evaluation(CIE) system at the institutional level (250 words)

Our college is affiliated to the Veer Narmada South Gujarat University, the university introduced choice based credit system in 2011-12. We follow the semester system designed by the university with 20 marks internal and 50 marks external in each semester. For internal assessment, a total of 20 marks are allocated, with 10 marks designated for internal tests and the remaining 10 marks distributed among various components such as assignments, presentations, attendance, group discussions, and other relevant assessments. We computerized test papers and evolution sheets. Most of our examination transactions are computerized. We have CCTV system in all classes as per the norms of the university.

2.5.3 – Academic calendar prepared and adhered for conduct of Examination and other related matters (250 words)

The college takes the initiative to establish the academic calendar, with Heads of Departments (HODs) assigning curriculum sections to respective teachers. Veer Narmad South Gujarat University serves as a primary source of guidelines and circulars from the UGC and state government, disseminating important information regarding curriculum amendments, changes, or modifications through circulars, notices, and emails. Faculty members actively contribute to syllabus formation through their participation in the Board of Study for their respective subjects, which the university revises every three years. The university also organizes Vyakhyan Mala lecture series, inviting subject experts to enhance understanding of the curriculum. Additionally, both the university and the Knowledge Consortium of Gujarat (KCG) schedule various curriculum-based workshops, with support from BISAG for curriculum enhancement programs. Faculty members are encouraged to engage in workshops focused on effective curriculum implementation. They also play a role in recommending books for library purchases and subscribing to journals and references aligned with curriculum requirements. The college provides essential facilities such as internet access, smart classrooms, printers, photocopiers, and scanners to support teaching and learning activities effectively.
